n the night of March 24, The Reverend Greg Proctor of Chapel of the Cross, Rolling Fork, got an unexpected call from the church's alarm company alerting him that a fire alarm had gone off in the building. Perplexed, he gave his Senior Warden, Charles Weissinger, a call.

"I called him and he said, 'I can't talk right now, there's a tornado going over my roof," says Proctor. "And I thought, my Lord in heaven, what is going on?"

What was going on was an extremely powerful EF-4 storm, the most destructive of an outbreak of tornadoes that did extensive damage in communities across central and northern Mississippi, including the towns of Midnight, Silver City, New Wren, and Amory.

Weissinger and his wife, Anne, had their 5-year-old grandson, Fisher, spending the night with them when they heard a freight train approaching their house. Knowing there were no tracks nearby, Weissinger grabbed the young boy and ran downstairs.

"I laid down on Fisher at the landing," he recalls. "Anne was at the bottom of the stairs. Glass and debris flew just over my head. Anne dove for the couch in the living room. The stairs to the attic blew down and insulation rained down on us. Fisher was about to graduate from kindergarten. I asked God to take me and spare him if

possible. Then it was gone. Three minutes from beginning to end."

In those three minutes, the storm had taken with it much of the town of Rolling Fork—78% of structures in the town were damaged and, even more tragically, 17 lives were lost. For many, including some who lost their own homes, the full gravity of what had transpired set in the next morning when they found that the Chapel of the Cross, having stood at the corner of Hicks and McLaurin Avenues since 1924, had been reduced to rubble.

"It brings tears even months gone by just thinking about that day," says parishioner Elise Cook. "The church being gone is like a death in the family—the hurt. The destruction was overwhelming; there was no way to take it all in. A kind of numbness set in for days."

As unprepared as Rolling Fork had been for the literal storm of the 24th, they were not much better prepared for the figurative storm that arrived on the 25th. Search and rescue crews, emergency management personnel, contractors, insurance adjusters, and 'disaster tourists' descended on the town.

In the midst of it all, parishioners and friends of Chapel of the Cross pitched in on a salvage mission. Proctor recalls arriving that morning to find people crawling over the rubble to get to the sacristy, where



they saved communion vessels, altar hangings, and candlesticks. The altar, organ, cross, and communion rail were recovered. Miraculously, the parish's banner survived.

"It was dangerous," says Proctor, "but I was grateful they were doing it."

But what was salvaged in Rolling Fork threw into sharp relief just how much had been lost—half-century old oak trees, Reconstruction-era buildings. Parts of

Rolling Fork that had once been full of businesses and homes now offered half-mile views in every direction.

Amid the chaos, there were helpers—people and groups from near and far came to aid the cleanup effort. Local farmers used their equipment to move debris to curbs so it could be cleared by FEMA. Church groups from other states poured in, along with donations from around the country as tiny Rolling Fork was, for a brief moment, a national news story. Post-disaster attention fades quickly, however, so the challenge

of rebuilding ultimately fell to the locals. The church has remained determined even as much of the press moved on.

"I have faith," says Proctor. "We are an Easter people—we believe in the Resurrection, and Chapel of the Cross is going to move from destruction to resurrection."

Less than a year after that destruction, much progress has been made—after many months holding services at Goodman Memorial United Methodist Church in Cary, Mississippi, at the generous invitation of Pastor Mary Stewart, the Chapel parish held Christmas Eve services in their newly rebuilt Parish Hall. The rectory, which was also partially damaged, has been repaired.

Plans for the new sanctuary are in place, with an aim of recapturing as much as possible the feeling of the nearly century-old structure it will replace. After many phone calls to churches and dioceses around the region, Weissinger located some historic stained-glass windows owned by the Diocese of West Tennessee, which they agreed to sell.

The windows, which had been forgotten in storage for decades until they were found in 2020, were from the chapel of Church Home Orphanage, to which Chapel of the Cross has a meaningful historical connection. The church, as a newly-formed parish in the 1870s, were supporters of "Constance and her Companions," the group of nuns also known as the "Martyrs of Memphis," who worked to save the lives of children at the orphanage during the yellow fever epidemic of 1878.

Replacing buildings and material things, of course, will not immediately repair the rift that was cut through the Rolling Fork community on March 24th, but having a physical home, Proctor points out, gives the people of the church—God's true instrument in the world—a place from which to do God's work.

"I'd like for the larger state to know that Rolling Fork is not finished," he says. "We're still here, still worshiping. We're going to keep on working and rebuilding, helping people find housing, keeping people fed. We're still at it, and we can use all the help we can get."

# **Electing a Bishop**


he Mississippi Episcopal Council meets on February 2-4, 2024 to elect the XI Bishop of Mississippi. Have you ever wondered, how do we Episcopalians actually elect a bishop? Is there white smoke billowing in the air when a bishop is elected?

At the Council meeting, electors are divided into two separate orders. Lay delegates, chosen by the parishes and missions of the diocese, along with one youth delegate from each convocation, comprise the lay order. Ordained priests and deacons canonically resident in the diocese comprise the clerical order. If a two-thirds majority of each order is present, the successful candidate must receive a simple majority vote from each order to be elected Bishop. Successive ballots will be conducted until the new Bishop is elected. If less than two-thirds of a particular order is present, then the successful candidate must receive a two-thirds vote from that order to be elected.

At this Council, electronic voting will replace the older, slower method of using paper ballots. Audience response keypads (clickers) will be issued to all delegates and clergy. This will allow the results to be tabulated almost instantaneously. There will be pauses between each ballot, allowing designated members of the Transition Committee to personally convey the results to each Candidate, who may or may not be present in the building. Candidates then have an opportunity to briefly reflect on the results and decide if they wish their candidacy to continue in future ballots. Following this consultation, the results of each ballot will be reported to the Council by Bishop Seage, who will preside. The next ballot will then begin.

Upon the election of a new Bishop by the Council, the President of the Standing Committee will speak to the successful candidate. If the candidate accepts election, the Bishop will then formally announce the selection of the new Bishop-elect. If the candidate is available, they will be introduced to the Council.

Following the voting, it is very important that all voting clergy and delegates wait to sign formal documents testifying to the election of the new Bishop. These testamentary letters officially convey the results of the election to the Presiding Bishop and to other individuals and entities. Preserved for posterity, several hang on the walls of the Allin House.

# Reports to the 197th Annual Council

# All Saints' Episcopal School

Again, this year's theme seemed to revolve around weather extremes. The prolonged sub-freezing temperatures in early winter, significant spring storms, and baking hot temperatures accompanied by several months of drought combined to cause major damage to the campus landscaping. Meteorologically speaking, the cool, wet autumn is this year's saving grace.

For all intents and purposes, the AmeriCorps and FEMACorps programs are back to normal having graduated two classes and inducting two full classes to replace them, over 300 participants in calendar year 2023. The teams have supported various community projects and vital recovery projects all over the United States as well as Guam and Puerto Rico.

Despite the high temperatures this summer, the lack of rain did allow us to make headway on building maintenance and take the first steps on repairing some of the worst of our erosion problems. And the drought has prompted us to look harder at rainwater harvesting and the damaged planting beds will give us the opportunity to increase and improve our pollinator habitats. When God shuts a door, He opens a window.

In addition to these projects, next year will see the completion of another round of security enhancements and the replacement of Green Hall's decades old chiller system. No doubt 2024 will present an array of unique challenges, some expected, but no matter what comes, the team we have here is up to the task.

## **Archives and History**

Interest in the diocesan Archives expanded in 2023. The twenty or more reference inquiries included many parishes asking about their history or how best to preserve their archival records (e.g., St. Stephen's, Columbia; St. Christopher's, Jackson; St. Philip's, Jackson; Chapel of the Cross, Rolling Fork; St. Mary's, Bolton; All Saints', Tupelo; Mediator, Meridian; St. James', Port Gibson; and St. James', Jackson). Information from the Archives was provided to the Transition Committee for the new bishop, and to individuals researching Richard Wilmer, the ordination of women, Dhurrie Hardin, voting rights of early African American parishes, and the extinct congregations of St. Philip's, Kirkwood (Madison County); St. Andrew's, Salem (Benton County); and St. Sylvanus', Pinckneyville (Wilkinson County).

After two well-attended sessions at annual council in Natchez on Collecting and Preserving Church Archives, I consulted onsite and at the Allin House about the archival records of Grace Canton. The Archives received several interesting donations during the year, including records from the Rev. Dr. David Langdon, who served as Parchman EPM Chaplain, 1994-2007; and architectural drawings of Gray Center.

Work continued throughout the year on the project, funded by the Historical Society of The Episcopal Church, to digitize video tapes. Events documented on the twenty-six tapes digitized by iMemories included the 100th year celebration of Resurrection, Starkville; consecration of Bishop Scantlebury in Panama; 90th anniversary celebration of St. Paul's, Meridian; dedication of the parish center at Chapel of the Cross, Madison; retirement of Bishop Duncan M Gray Jr.; ordination of the Rev. Canon David Johnson; statewide celebration of Black Church Ministries in 2003; diaconate training; and St. Michael's Farm in the 1990s.

The primary work during 2023 focused on researching and beginning to plan initiatives relating to the 2026 celebration of the Diocese's 200th anniversary. Considerable time was spent reading annual council journals, 1826-1954, searching for information about the treatment of enslaved individuals before the Civil War and African American parishes in the post-war period, and identifying topics that might warrant additional examination or reconsideration.

An advisory committee comprised of individuals throughout the diocese was convened and met via Zoom. I drafted a brief history of the diocese, which will be added to the website in 2024; and compiled an initial draft of a two-page timeline for use by facilitators in racial reconciliation and healing training. I participated on a racial reconciliation panel at annual council, talking about the role of diocesan history in truth-telling; served as facilitator at racial reconciliation training for the Bishop Search Committee, and attended the two-day Equal Justice Initiative Pilgrimage to Alabama in September. I also coordinated an effort to apply for an historical marker commemorating Holy Trinity Episcopal Church in Mound Bayou. Lastly, I readied the Archives for the arrival of the 11th Bishop of Mississippi, attending the listening session for the diocesan staff and moved more than 70 cubic feet of materials and preservation supplies to offsite storage.

# **Bishop Search Committee**

The search for the 11th Bishop of the Diocese of Mississippi began on December 27, 2022, when Bishop Seage issued a formal communication to the diocese calling for the election of his successor. The Standing Committee met with the Rt. Rev. Todd Ousley, Bishop of the Episcopal Church's Office of Pastoral Development, and the Chancellors of the diocese to chart a course for the election of the next diocesan bishop. Throughout January, they interviewed four search consultant candidates and then voted unanimously on January 28 to call the Rev. Ron Clingenpeel as search consultant.

The Standing Committee asked Alice Perry, St. James', Jackson to serve as chair of the Search Committee and solicited applications from people, both lay and ordained, who were willing to serve on the committee. Fifteen committee members were chosen from the different convocations to represent various sizes of churches and a broad spectrum of experiences in the church. The members from the

Clergy Order were: the Rev. CJ Meaders, St. Columb's, Ridgeland; the Rev. Tom Fanning, Chapel of the Cross, Madison; the Rev. Dcn. Betty Melton, St. Francis of Assisi, Philadelphia; the Rev. Dcn. Sarah Stripp, St. Andrew's Cathedral, Jackson; and the Rev. Morris Thompson, Mediator, Meridian. The members from the Lay Order were: B.W. Curry, Ascension, Hattiesburg; Rebecca Fish, Redeemer, Biloxi; Susan Lee, St. Stephen's, Indianola; Alice Perry, St. James', Jackson; Richard Price, St. Alban's, Bovina; Brian Pugh, Resurrection, Starkville; Goldia Revies, St. Christopher's, Jackson; John Samonds, St. Peter's, Oxford; Stephen Stray, St. Andrew's Cathedral, Jackson; and Paula Vaughan, All Saints', Grenada. The Rev. Thompson later resigned after accepting a call to be rector at a church in a different diocese.

The Search Committee was charged with gathering information about the diocese through prayerful listening and discernment, prepare a diocesan profile, educate the people of the diocese about the ministry of a bishop, and recruit and receive nominations to discern a slate of three to five candidates for the Standing Committee and the diocesan council to consider.

The Committee's first meeting was a joint session with the Standing Committee on March 31 followed by committee training on April 1. They began planning listening sessions and a diocesan survey. Listening sessions were held in May in Hattiesburg, Gulfport, Meridian, Tupelo, Greenwood, Southaven, and Ridgeland. The host churches offered warm hospitality and over 400 people attended. Several members of the Search Committee were at each of the sessions. There was also a listening session held for diocesan staff and a separate one for the clergy. Meanwhile, a subcommittee began working on a diocesan profile and negotiated with Holy Cow! Consulting to conduct the survey. Over 1,000 people completed the survey, and the results gave the committee a clearer picture of what people throughout the diocese thought about the church and their hopes for the future.

Within days of the training retreat, a dedicated website was created (msbishopsearch.com) and social media accounts were created to keep people informed about the search process. These were in addition to regular updates in *The Mississippi Episcopalian* coupled with articles about the role of bishops historically and today. The Rev. Jennifer Southall, St. Peter's, Oxford wrote the educational articles, and the committee appreciated her involvement.

The Diocesan Profile was released on June 28. It described Mississippi, the Diocese of Mississippi, and what the priorities are for diocese, which the committee learned from the listening sessions and the survey. Those priorities are strategic, leadership development, and congregational support. In addition to committee members working on the profile, other people played significant roles, including Jack Garner, St. Peter's, Oxford who helped with the writing and editing and Dominque Pugh, Resurrection, Starkville who was the graphic designer.

With the publication of the profile, the Committee began to solicit nominations and applications. In addition to diocesan-wide announcements in churches, emails, and social media, the search was advertised in the Episcopal News Service and emails were sent to seminary deans, bishops, and various Episcopal organizations. Applications were accepted through Friday, July 21, and the response far exceeded the Search Committee's expectations.

Prayerful discernment continued through August as the Search Committee interviewed the nominees, carefully studied their responses to written questions, and talked with the nominees' references. It was an honor to get to know so many outstanding clergy who were willing to discern a call to be the next bishop of the Diocese of Mississippi. From the numerous nominees, the committee selected a small group to be invited to a discernment retreat.

The discernment retreat was an intense three-day gathering of the Search Committee and the semi-finalists. Each nominee was asked to give a presentation to the full committee and to participate in discussions with small groups of committee members. An entire morning was devoted to going into details about the diocesan survey and the diocesan finances and organization. There were also informal opportunities for the committee members and nominees to get to know each other better and several worship services, including a closing Eucharist.

Several days after the retreat, the Committee met for a morning prayer service and to make a decision about who the final five candidates would be. Those finalists were presented to the Standing Committee on Friday, October 20, and the slate was announced on November 1.

The members of the Search Committee were honored to serve and deeply appreciate the many people who completed the survey, attended the listening sessions, provided pictures for the profile, and offered insight and advice. We especially appreciated the many prayers for the search process, the committee, and the nominees.

Calendar year 2023 was a fun and meaningful year for Canterbury MSU. #### Chancellor

The Chancellor of the Diocese attended the meetings of the Trustees of the Diocese and the Chancellor/Vice Chancellors attended meetings of the Executive Committee and assisted as requested.

Conducted research, rendered legal opinions and conferred with the Bishop, the Canon to the Ordinary, and the CFO and lay leaders on a variety of issues affecting or involving the Diocese.

Studied and reviewed Roberts Rules of Order, the Council Agenda, worked with both Vice Chancellors on related pre-Council issues, and attended the 196th Diocesan Council held at Trinity Episcopal Church in Natchez, Mississippi, and assisted as requested.

Reviewed the bi-monthly issues of Church Law and Tax Report regarding court decisions involving churches, parishes, dioceses, etc., and called to the attention of the Bishop and the CFO the matters of importance to this Diocese.

Studied, reviewed, conferred and met with the Bishop, the CFO, the Trustees and representatives of Merrill Lynch and Vector Money Management, Inc. and Trustmark National Bank involving the management of the Diocese's investment portfolio.

Conferred with the Bishop, Standing Committee, Presiding Bishop's Bishop for the Office of Pastoral Development, Canon to

the Ordinary and Chief of Staff, Search Committee, and Transition Committee and both Vice Chancellors on canonical considerations and preparations for the search for the 11th Bishop of the Diocese, including elements of a Letter of Agreement to be entered by the Standing Committee with the Bishop-Elect. The Chancellor and Vice Chancellor Ireland attended the Discernment Retreat hosted by the Search Committee and interviewed the candidates for Bishop.

The Chancellor and both Vice Chancellors attended planning meetings with the Bishop, Canon to the Ordinary and Chief of Staff and Chief Financial Officer.

Conferred with the Bishop and Canon to the Ordinary and Chief of Staff on vacancies in the General Convention deputation.

Conferred with the Bishop and Canon to the Ordinary and Chief of Staff and monitored numerous activities and developments for the Diocese of Mississippi, the Trustees of the Diocese, certain parishes, missions and other diocesan institutions in the case styled as In re: Boy Scouts of America, filed in the United States Bankruptcy Court for the District of Delaware. This matter is now concluded for all practical purposes.

With the assistance of both Vice Chancellors, conferred extensively with the Bishop, Canon to the Ordinary and Chief of Staff, the Executive Committee, Trustees, Chief Financial Officer and other Diocesan leaders on a wide variety of financial, contractual, real property, insurance, and related issues arising out of the cessation of operations at the Duncan M. Gray Camp and Conference Center. Worked extensively with the Bishop and Trustees on contract review and negotiations with multiple potential purchasers for the Conference Center property located on the north side of Way Road, resulting in signed contracts to sell the undeveloped land north of the Conference Center area to two separate purchasers. These two contracts are expected to close prior to year-end 2023.

Reviewed and conferred with the Canon to the Ordinary and Chief of Staff concerning the interpretation of the governing instrument of, and use of funds from, the Gray Center Special Maintenance Fund.

The Chancellor and both Vice Chancellors conferred with the Bishop, Canon to the Ordinary and Chief of Staff on arrangements to conduct the 2023 summer camp program at Camp Bratton Green, the physical improvements, policies and procedures for sickness and cabin protocols, contract reviews, licensure and permitting matters, training, and related logistical considerations.

Conferred with the Bishop, Trustees, Board of Directors and others, especially the former Canon for Administration and Finance, and worked with representatives of AmeriCorps/NCCC and their legal counsel and other representatives, on contract, leasehold, corporate governance matters, succession planning and related legal issues concerning the All Saints Episcopal School in Vicksburg. Vice Chancellor Ketner prepared and recorded a cancellation of an outstanding deed of trust for All Saints School. Attended a Board of Directors meeting to review operations and authorize the first distribution of funds to the four owning dioceses pursuant to a revenue sharing agreement previously approved by the Board of Directors.

Conferred with the Bishop, Canon to the Ordinary and Chief of Staff and legal counsel for an independent trustee concerning an ongoing trust matter involving All Saints Episcopal School.

Conferred with the Bishop, Trustees, the Canon to the Ordinary and Chief of Staff and representatives of Trustmark National Bank on financing matters involving the existing financing relationship between the Trustees and Trustmark National Bank involving the indebtedness incurred by the Trustees for congregations on the Gulf

Coast following Hurricane Katrina. Coordinated with the Trustees and Canon to the Ordinary on the payment in full of the outstanding deed of trust encumbering St. Mark, Gulfport.

With the assistance of both Vice Chancellors, worked on real property matters for Redeemer, Biloxi, including a review of a title examination and quiet title action covering the riparian beach front property owned by the Parish; coordinated with the Trustees of the Diocese, Rector, Vestry representatives and legal counsel to Redeemer, Biloxi on the sale of the property and related closing logistics; and worked on other property matters for St. Alban, Bovina; St. Christopher, Jackson; St. Timothy, Southaven, and a vacant parcel owned by the Trustees in Jackson.

The Chancellor and both Vice Chancellors conferred with the Canon to the Ordinary and Chief of Staff and parish leadership on a variety of employment matters involving Gray Center; Chapel of the Cross, Madison; and a Jackson Parish.

Vice Chancellor Ketner conferred with the Canon to the Ordinary and Chief of Staff on background check processes and prepared guidance regarding Fair Credit Reporting Act compliant background checks.

Worked with the Bishop, Canon to the Ordinary and Rector of Christ Church, Vicksburg to establish the governing document for a newly created endowment fund established by a former member of the Parish.

Conferred with the Bishop, Canon to the Ordinary and Chief of Staff and the Senior Warden of Chapel of the Cross, Rolling Fork, on insurance claims and property matters arising out of the March 2023 tornado that struck Rolling Fork and the Parish.

Conferred with the Bishop, former Bishop Gray, Canon to the Ordinary and Trustees and members of Nativity, Water Valley on (i) a lease of property by the Trustees of a building in Water Valley across the street from the Church, and (ii) a transfer to the Trustees by means of a charitable donation of a membership interest in a limited liability company that owns the leased premises.

Vice Chancellor Ireland worked with intake officers and the reference panel on Title IV matters.

Vice Chancellor Ireland attended the National Chancellors Conference held in Orlando, Florida and consulted with a Parish on a potential litigation matter.

Conferred with the Bishop and Canon to the Ordinary and Chief of Staff and provided advice regarding mitigation of risks to a Parish that may have experienced a business email compromise event.

Conferred with the Canon to the Ordinary and provided advice regarding a potential incident reporting inquiry from a rector in the Diocese.

Conferred with the Bishop and Trustees on strategies for addressing deferred maintenance and repair needs of small congregations across the Diocese.

After assisting previous Chancellor George Hewes for five years and serving as Chancellor for 22 years, the Chancellor has notified the Bishop of his plan to retire as Chancellor of the Diocese following the 197th Council. The Chancellor will continue to serve in an Emeritus capacity until the consecration of the 11th Bishop of the Diocese.

## **Congregational Vitality**

The Diocese of Mississippi is one of six dioceses selected into a three-year Vitality Improvement Program (VIP) designed for small congregations. The program is designed specifically to provide reduced-cost resources, coaching, and consultation to small congregations that will assess their vigor and sustainability, then develop effective vitality and sustainability improvement strategies by better engaging the neighborhoods they serve.

Calendar year 2023 was the first year of this three-year VIP program. Eight congregations were selected and participated: Ascension, Hattiesburg; St. Timothy's, Southhaven; All Saints', Grenada; St. Christopher's, Jackson; Redemer, Brookhaven; St. Alban's, Bovina; and St. Mary's, Holy Trinity, and Christ Church, Vicksburg. Congregations each completed vitality assessments, reviewed neighborhood insights reports, and began working on a 90-day micro strategy for new missional opportunities.

# Daughters of the King (DOK)

The Order of the Daughters of the King is an order for women who are communicants of The Episcopal Church, churches in communion with it, or churches in the historic episcopate but not in communion with it. The Order of the Daughters of the King in Mississippi is composed of 22 Chapters and seven Daughters at-large in parishes and missions throughout our state. We have approximately 303 members, and we are one of the nine states that constitute Province IV. Our National Office is in Woodstock, GA. The mission of The Order is the extension of God's Kingdom, especially among women and girls, through Prayer, Service, and Evangelism. The Order of The Daughters

of the King is organized as a religious order although not living in a confined community. Each Daughter takes a lifetime vow to live by the Rule of the Order which requires a spiritual discipline of daily prayer, service, and evangelism. We are an order, not an organization, and our bylaws preclude us from raising funds.

This year the Daughters worked together providing hygiene protection for young ladies where needed across the state which was our first statewide project. Daughters continue within their own orders providing meals to families in need, preparing meals for students to carry home on weekends and snacks for afterschool, providing food to the food pantries, providing gifts on holidays for residents in nursing facilities, knitting prayer shawls for the ill, knitting/crocheting hats, shawls, and mittens for the homeless. Daughters participate in altar guilds, choir, Vestry, flower guilds, Episcopal Church Women, and as LEMs. We send notes to congregants, clergy, and our bishop. Daughters host retreat days, clean clergy robes, albs, and altar linens. The Daughters provided scholarship assistance through the Education Equal Hope for students in Costa Rica, Haiti, Ecuador, and Rwanda. Daughters assisted in providing meals for congregations after services.

Our most recent Province IV Diocesan Presidents' Annual Report shows that in our chapters we study selected material of a spiritual nature. Chapters keep a confidential prayer list and read the Prayers of the People at the Sunday services. At the Service of Admission each new Daughter receives her cross which is a Fleury cross inscribed in Latin "Magnanimiter Crucem Sustine" which means "with heart, mind and spirit uphold and bear the cross." At the base of the cross are the letters "FHS" which stand for the motto of the Order "For His Sake."

# Diocesan Altar Guild (DAG)

After a hiatus due to COVID, the Diocesan Altar Guild is back! Under the leadership of our last president, Judy Ketchens, our convocations began meeting again, and we met in all convocations in 2023.

The purpose of the Diocesan Altar Guild is to assist the Bishop in the care of the altars in his Diocese. The purpose is carried out by: (1) providing a center for the exchange of reverent information among the altar guilds in the diocese; (2) providing workshops and training opportunities for improving skills; (3) accepting responsibility for the care of altars utilized at Diocesan-wide events and at the discretion of the bishop; and (4) furthering fellowship, inspirations, and cooperation among those who serve God in this ministry.

Two ongoing projects of the DAG are the Supply Closet and stoles for the new deacons. The Supply Closet is a means to recycle linens, vestments and vessels no longer needed by a parish. Dr. Mary Jackson chairs this project and regular posts are available on the

DAG website (dag.dioms.org) and on Facebook, The Diocesan Altar Guild. Lollie Everett chairs our Needlework and Stoles committee and Denise Brown is now making the beautiful red stoles presented by the DAG to newly ordained deacons and priests in the diocese.

All diocesan church altar guilds are encouraged to join the Diocesan Altar Guild. The annual dues are \$35 for parishes, \$25 for missions, and \$10 for mission stations. Your church Altar Guild dues are used to care for the diocesan Eucharist vessels, linens etc. and goes toward the rental fee to house these articles as well as the cost of the stoles and other materials that are needed to accomplish our responsibilities to the diocese. An updated list of your church's altar guild is asked for when dues are submitted. This helps the DAG with record keeping and serves as a means of communication throughout the diocese.

The 2023 Annual Meeting of the DAG was held at St. Andrew's Cathedral, Jackson in April. Jan Smith, Sowashee Convocation, St. John's, Laurel, gave an informative presentation on weddings. The meeting provided a springboard to our convocation meetings which were held in July and August. St. George's, Clarksdale was the site of the Delta Convocation; All Saint's, Grenada hosted the Coldwater Convocation; Incarnation, West Point hosted the Tombigbee Convocation.

The DAG will have a big year in 2024 with annual council, and the consecration of a new bishop, and we are pleased to announce that our annual meeting will be at St. John's, Laurel, on Saturday, April 20. Stay tuned.

# Diocesan Formation for Children & Youth

Our congregations, most of which would be considered small, are finding that age-divided, weekly programs are not supporting our young people, or the adults who love them and take care of them, in their faith formation as much as they once did. The pattern of many households is to attend church less regularly. We do have a handful of congregations that are still functioning with weekly programs as their main formation support, but research and trends across The Episcopal Church are showing that even for larger congregations, program models are on the decline. Instead of programs, relationships are being emphasized in formation of all ages – relationships within households, with older and younger people in congregations, as well as others the same age.

A benefit of our diocesan structure is the natural, built-in opportunity for the church to gather outside of the congregation. Several of our convocations have found success by working together. Youth coordinators in each convocation were appointed to help keep track of who is organizing youth formation in congregations and to organize opportunities for youth within their convocations to gather. The Central Convocation EYCs meet once a month for larger events and the other Sundays of the month on their own. Five of the Coast Convocation churches are meeting weekly as a joint EYC. Working together has allowed these churches to share in the resources needed (money and people!) to provide a safe space for these youth

to explore and discover their faith. And after fall convocation youth events in other convocations, several are hoping to get together more than once a year! Central: Lisa Saucier; Coldwater: Hayden Hershfelt; Delta: Cyndi Saia; Old River: the Rev. Elisabeth Malphurs (interim); Coast: Whitney Robinson (interim); Sowashee: the Rev. Katie Sorey (interim); Tombigbee: Kamme Riddle.

The annual AWWY (adults working with young people) retreat was resurrected after a hiatus during the pandemic. Twelve adults across the diocese were in residence to share and learn from one another. By the time of Annual Council, AWWY will have gathered again in person on the Gulf Coast to attend the virtual continuing education conference offered by FORMA, the grassroots organization of formation practitioners within the church. It has been good to gather in person again!

# The Duncan M. Gray Center | Camp Bratton-Green

At the 2023 Annual Council we learned that the negotiations that had been pending since the summer of 2022 had been abandoned and that the Gray Center sale was once again off. During the months following the initial negotiations, the approved 2023 budget for Gray Center had been prepared assuming that the sale was a done thing and that the expenses for the North side would not be repeated.

COVID had an enormous impact on the North and South sides of Way Road. Both sides had been shut down and were mostly mothballed. A skeleton crew was left to oversee the maintenance and the basic operations. From August 2020 until the Spring of 2022, nothing much happened. An empty facility is a deteriorating facility. The decision had been made to wait until 2023 to reopen the camping program. Due to the hard work of many volunteers and staff and the partial success of the Seeds You Sow capital campaign to benefit Gray Center, Camp Bratton-Green did open for the 2022 camping season. While numbers were lower than they had historically been and, with a full complement of new Permanent Staff members, the directors and volunteers more than pulled it off! The program at Camp Bratton-Green proved to be resilient one more time. Thanks to the persistence of many members of the CBG Alumni Association and countless others, six cabins were refurbished and are now air conditioned, along with the south side dining hall. It is a new day!

Before 2023 ends, the CBG program will have served over 650 campers and staff. We have some room to grow that number. Two of the sessions had a combined total of over 58 campers on the waiting list. One of the many projects in the planning stage is the remodel of Cabin 4. With some repair and remodeling work yet to be done on the Rose Hill House, we will have added over 15 rooms to our capacity.

In addition to the CBG programs, we have been welcoming several Episcopal and other groups who are using two of the Cottages (Chalets) on the North side, Rose Hill and the cabins on the South side. Cathy Davis is our contact for reservations (cathy@graycenter.org). Many of the weekends and some entire weeks have been booked. DOY and the CBG Alumni Association have regularly scheduled work weeks and weekends. The South side is in better shape than it has

been for some time because of the care shown by staff and volunteers.

We are excited about 2024! A new registration/reservation/application system; improvements and repairs to the Lake House, Rose Hill, and Cabin 4; a revamped website; the continued support of the Bishop, the Executive Committee, Gray Center advisory board, and The Trustees of the Diocese; and, the recommitment and enthusiasm of those committed to the CBG program will insure that Gray Center will continue to fulfill its mission of transforming lives and providing inclusive hospitality.

# Ministry with LGBT Persons

The mission of the Committee on Ministry with LGBT Persons is to continue Christ's work of reconciliation and unity among all persons by attaining full inclusion of LGBT persons, and their allies, in the life of the Church. The theme of the retreat was "Took, Blessed, Broke, Gave", leading participants in meditations and activities on each of these acts of Jesus described in the gospels. At the opening of the retreat, Bishop Seage welcomed Episcopalians, Catholics, Presbyterians, Jews and Baptists, hailing from Louisiana, Mississippi, and Alabama. The retreat was attended by gay, lesbian, transgender, and bisexual persons as well as straight allies. The Rev. Carrie Duncan, Rector at Trinity, led the retreatants in art as a meditation on each step. This was truly a retreat where all found a "welcome" as we walked a path of love, grace, hope, joy and peace. Attendees for the retreat ranged in age from 16 to 85.

Because of the overwhelming response to the retreat, the Committee will be working to establish more one-day opportunities for gathering in 2024 as well as reestablishing the weekend retreat. Cynthia DeDakis led a discussion group about resources from the RSCM and about starting chorister programs in churches.

As we prepare for our 49th conference next summer, we have engaged Dr. Marilyn Keiser, (retired organ professor at I.U.) Mr. Matthew Brown (OCM at St. Luke's in Atlanta), Mr. Dwight Thomas (Canon for Music at the Cathedral of St. Peter in St. Petersburg, FL), and the Rev. Erika Takacs to be our faculty. Our theme will be: "With the Spirit's gifts empower us for the work of ministry." It is our hope that more musicians throughout the diocese will be encouraged and enabled to attend. We continue to strive in keeping costs low for attendees while providing "mountain top" experiences that will keep them inspired, and keep the music ministries of our diocese vital and thriving.

## Racial Reconciliation Task Force

The mission of the Church as stated in the catechism is "to restore all people to unity with God and each other in Christ." The Racial Reconciliation Task Force of the Diocese of Mississippi takes the Church's mission seriously. This ministry of promoting racial healing is the crucial work God's people can do to further the Gospel. The task force serves to amplify the bishop's ministry of reconciliation in the Diocese.

The Episcopal Church's Becoming Beloved Community vision

frames a path to address racial injustice and all other forms of oppression. This has become TEC's never-ending, lifelong commitment to grow as communities of reconcilers, healers, and justice-makers. It upholds four spiritual disciplines: Telling the Truth, Proclaiming the Dream, Repairing the Breach, and Practicing the Way. Because this is the work of spiritual formation, and not simply a training or seasonal program, the diocesan task force is the most joyful cheerleader encouraging congregations to exercise these disciplines. This ministry inspires the diocese to embrace the multicultural future of the church.

The task force has members and leadership spread throughout the Diocese. Each month, there is a virtual gathering for an hour of networking, enrichment and organizing. Special guests joining for fellowship and wisdom sharing: John Ashworth and the Rev. Tom Momberg from the Lynching Site Project in Memphis; Von Gordon, Jennifer Heath, and Chauncey Spears from the Alluvial Collection; the Rev. Valerie Mayo from the Episcopal Seminary of the Southwest, Suzanne Edwards-Acton from My Work To Do; Dr. Robert Jones promoting his book, *The Hidden Roots of White Supremacy*; Dr. Mary Coleman promoting her book, *Land, Promise and Peril*; Superintendent Kathleen Bond with Natchez National Historical Park, NPS.

Day of Dialogue for Racial Healing and Relationship Building - Over 200 participated in the diocesan sponsored anti-racism workshops in 2023. Thanks to St. James', Jackson (78); St. Peter's bythe-Sea, Gulfport (42); Resurrection, Starkville (57); the Bishop Search Committee (11); and the Transition Committee (14) for sponsoring workshops in 2023.

These day-long, shame free workshops have a compelling agenda filled with storytelling and faith-sharing, connections, and deepening understanding mainly about oneself. This spiritual formation is meant to enhance loving speech, compassionate listening, and strength skills for healthy conversations about sensitive issues. These sessions are facilitated by seasoned leaders competent in shaping a prayerful environment. When participants use the same vocabulary, new conversations for racial healing take place.

**Sacred Ground** - Sacred Ground is a film-based dialogue series on race and faith. Small groups walk prayerfully through the chapters of American history of race and racism. This year, circles met at St. Paul's, Corinth; Nativity, Water Valley; and St. Andrew's Cathedral, Jackson.

**Retreats and Revivals** - The Rev. Ed Bacon led the Lenten 2023 Retreat, Spiritual Formation furthering Beloved Community. Over 110 participated in this two-session workshop at St. Andrew's Cathedral. Gloria Carter Dickerson led the Advent 2023 Retreat, Making Good Room, at St. Christopher's, Jackson.

## **Standing Committee**

The Standing Committee plays several important roles in the life of the diocese. Canonically, Standing Committee approval is required for all purchase, sale, or lease of property, and any time a congregation undertakes any form of indebtedness. The Standing Committee oversees certain funds used for mission and ministry. Actions such as the admission of missions and parishes to the diocese and the ordination of persons to the Diaconate and Priesthood require the consent of Standing Committee. The election of a bishop in The Episcopal Church requires consent of both a majority of bishops and a majority of diocesan Standing Committees. If the diocese becomes vacant, the Standing Committee becomes the Ecclesiastical Authority. Finally, its most important role is to act as a formal Council of Advisors to the Bishop.

The Standing Committee consists of four Clergy and four lay members, each serving four-year terms. Current members are: the Very Rev. Jody Burnett (President, term ends 2024), Mrs. Tish Goodman (Secretary, term ends 2024), the Rev. Abram Jones (term ends 2025), Mr. Jim Woodrick (term ends 2025), the Rev. Les Hegwood (term ends 2026), Mr. Buck Cooper (term ends 2026), the Rev. Elizabeth Wheatley-Jones (term ends 2027), and Mrs. Barbara Hammer (term ends 2027).

The Standing Committee began 2023 meeting during the 196th Annual Council in Natchez on Saturday, January 28, 2023. The Very Rev. Jody Burnett was elected president, and Tish Goodman was elected secretary. The Rev. Elizabeth Wheatley-Jones and Mrs. Barbara Hammer were both elected to serve four-year terms ending in 2027. The Rev. Abram Jones was elected to fill an unexpired term ending in 2025. The Standing Committee recognized retiring president, Mr. Jim Woodrick, who will remain on the Committee, and expressed appreciation to the retiring members, the Rev. Carrie Duncan and Mr. Adam Gwin for their gifts and service to the diocese and to the Standing Committee.

The Standing Committee continued its work, both in person and on Zoom, for the remainder of the year including five regularly scheduled meetings, and fourteen special called meetings, pursuant to the Standing Committee's Rules of Procedure. Upon the announcement of Bishop Seage's intention to resign, the Standing Committee had the added responsibility this year of overseeing the search for a new Bishop. To assist with this holy and historic effort, the Standing Committee contracted with the Rev. Ron Clingenpeel as our search consultant and formed two sub-committees to ensure a smooth search and transition process.

The Standing Committee wishes to express special appreciation to the members of the Bishop Search Committee for their faithful and diligent work in the search for eleventh Bishop. The Standing Committee also wishes to express special appreciation to the members of the Bishop Transition Committee for their faithful and diligent work in preparing for the election and consecration of our next Bishop. **Bishop's Council of Advice** - The Standing Committee met regularly with Bishop Seage to discuss a wide range of issues in the life of the diocese. The Standing Committee appreciates the important working relationship we have with the bishop. We have also expressed a desire for greater communication and collaboration between the diocesan leadership bodies and the diocesan office.

**Drennan and Development Funds** - The Standing Committee is tasked with the management and oversight of these funds. Accordingly, we received and reviewed the quarterly investment statements from these accounts.

Consents to the Ordination of Bishops - The Standing Committee consented to the election of eight bishops: the Rev. Justin S. Holcomb, Diocese of Central Florida; the Rev. Sally French, Diocese of New Jersey; the Rev. David G. Read, Diocese of West Texas; the Rev. Ann Ritonia, Armed Forces and Federal Ministries; the Rev. Carrie Schofield-Broadbent, Diocese of Maryland; the Rev. John T. W. Harmon, Diocese of Arkansas; the Rev. Jeremiah Williamson, Diocese of Albany; and the Rev. Kristin Uffelman White, Diocese of Southern Ohio. The Standing Committee withheld consent to the election of the Rev. Charlie Holt, Diocese of Florida.

Consents for Holy Orders - The Standing Committee is thankful for its fruitful relationship with the Commission on Ministry as we coordinated our separate roles and shared responsibilities in nurturing postulants and candidates along the pathway to Holy Orders. As required by the Canons, we reviewed files, made recommendations, and interviewed three postulants for ordination: Katie Sorey and Rufus Van Horn to the Sacred Order of Priests, and Tina Frizzell to the Sacred Order of Deacons.

**Real Estate Matters** - Regarding our responsibilities for dealing with matters of real estate and church indebtedness, we considered five real-estate matters, and consented to the sale/alienation of all five (St. Matthew's, Forest; Redeemer, Biloxi; Holy Trinity, Vicksburg; and two parcels of property at the Gray Center).

As a reminder to any churches wanting to sell, lease, or purchase property, the process for engaging the Standing Committee for consent can be found in our Rules of Procedure, which are published online on the diocesan website. Particular attention should be paid to Section 9 on page 11, entitled Real Property and Debt Issues.



#### **Explanation**

The production of plastic bottles has an extreme negative impact on the environment.

The bottled water industry generated roughly 600 billion plastic bottles and containers in 2021. This resulted in around 25 million tons of plastic waste — most of which is not recycled and ends up in landfills.\*

The waste pile is so gargantuan that it would be enough to fill a line of 40-ton trucks stretching from New York to Bangkok every year, according to the report.

Fossil fuels are the raw ingredient for the vast majority of plastics, which have a heavy carbon footprint from manufacturing through to disposal.

If the plastics industry were a country, it would be the fifth largest emitter of greenhouse gases in the world.

Around 85% of plastic water bottles, which can take up to 1,000 years to degrade, end up as waste. They also end up in the ocean, adding to a vast swirl of plastic waste that poses a serious threat to marine life.

The world's oceans are polluted by a "plastic smog" made up of approximately 171 trillion plastic particles that, if gathered, would weigh around 2.3 million tons.

In the environment, plastic bottles can break down into miniscule particles, called microplastics, which make their way into our food water, posing a potential risk to human health.

Plastic can also leach toxic chemicals, affecting animals that ingest it, contaminating the animal and human food chains.

General Convention Resolution 2009-A045 originated from the House of Deputies Committee on National and International Concerns

Here is the resolution, as approved at General Convention in full.

## 2009 - A045 A Resolution to Restrict the Use of Bottled Water and Practice Conservation

Resolved, That the 76th General Convention ask the Church to restrict the use of bottled water at General Convention and at other Church-sponsored activities where safe, because of the extreme negative environmental impact that attends its production, and be it further

Resolved, that every baptized Christian be encouraged to practice simple energy and water conservation techniques so that, by working together, we may restore the beauty of God's creation and ensure that this resource may again be available to all God's children in abundance.

These await shipment to Ukraine where they may give comfort to children separated from their homes and in some cases their family.

The Most Rev. Michael Curry November 7, 2023

You may know me as the pastor who is always talking about love, and I am. But today I am mindful that the urgency of love—true, sacrificial love that respects all of humanity—is not just a good feeling, and it is not easy.

We are called to a love that demands much from us. We are called to a love that tells the truth.

Today I raise my voice for love because more than 10,000 people have died in Gaza,\* including more than 4,000 children.

The violence is horrific, and the geopolitics are complex, but my call to love is simple: Stop the killing. Stop all of it. Stop it today.

We will not be silent while an entire population is denied food, water, electricity, and fuel needed to run hospitals. We cannot stand by while thousands of civilians die. Our partners in the region tell us they live in terror—that they feel they have died even while alive. They feel that the international community is tacitly sanctioning the killing of civilians and the bombing of schools, hospitals, and refugee camps.

Staying quiet in this moment would be a stain upon our souls and would deepen our complicity.

U.S. leadership must tell Israel to stop bombing civilian areas and allow access for full humanitarian aid to flow freely into Gaza.

Every human child of God—Palestinian and Israeli—deserves safety and security. We need to stop the killing. Today.

Vengeance will not bring back the dead. Retaliation will not repair the harm and the hurt. We are called to love, even and especially when it seems impossible. We must stop the next 10,000 from being killed. As Episcopalians, we must call upon our leaders—President Biden, members of Congress, and others—to be unequivocal that we need to stop the killing. Today. This is clearly what love demands of us.

# THE EXECUTIVE COMMITTEE OF THE EPISCOPAL DIOCESE OF MISSISSIPPI RESOLUTION ON PROCEDURES FOR ELECTION OF THE ELEVENTH BISHOP OF MISSISSIPPI

October 5, 2023

WHEREAS, on December 27, 2022, The Rt. Rev. Brian R. Seage, Tenth Bishop of the Episcopal Diocese of Mississippi ("Diocese"), issued a formal call for the election of his successor to serve as the Eleventh Bishop of the Diocese;

WHEREAS, the Standing Committee of the Diocese appointed a Chairperson and members to serve on a Search Committee to review the life and ministry of the Diocese through prayerful listening and discernment, prepare a diocesan profile for the search, educate the people of the Diocese on the election process and ministry of a bishop, and recruit and receive nominees to discern a slate of bishop candidates for the Standing Committee and diocesan Council to consider;

WHEREAS, the Standing Committee of the Diocese also appointed a Chairperson and members to serve on a Transition Committee to conduct the diocesan listening sessions (commonly called "Meet and Greets or walkabouts") with the slate of nominees; coordinate the Bishop election at Council, work with the diocesan staff, resigning Bishop, Bishop-Elect, Presiding Bishop, Commission on Liturgy and Music, and other appropriate groups around the Diocese to plan and carry out the consecration service and related activities; and arrange for the Bishop-Elect's transition into the Diocese;

WHEREAS, on September 20, 2023, the Standing Committee of the Diocese adopted a resolution setting forth the Petition Process for the election of a Bishop, which resolution is posted on the Bishop Search website and the diocesan website, and which Petition Process will be open beginning November 2, 2023 and end on November 8, 2023, whereby any petition candidates who successfully complete the same background check process required of other Search Committee candidates will be included in the Meet and Greets walkabouts and the names of candidates placed in nomination at Council;

WHEREAS, the Search Committee is completing its work and submitting to the Standing Committee a slate of nominees to serve as Bishop-Elect, which is anticipated to be announced on November 1, 2023;

WHEREAS, the work of the Transition Committee is ongoing and

will continue through the transition of the Bishop-Elect;

WHEREAS, the Executive Committee of the Diocese ("Committee"), acting under the authority of Canon 12, Section 1 of the Canons of the Diocese, shall have and exercise, in the interim between Councils, all the powers of Council, except as limited by Canon, and desires to adopt a resolution on procedures for the election of the Eleventh Bishop of Mississippi pursuant to Article XIII of the Constitution of the Diocese, which provides as follows:

THE CONSTITUTION ARTICLE XIII Election of a Bishop

SECTION 1. The election of a Bishop, a Bishop Coadjutor or a Suffragan Bishop, shall be made in the following manner:

- (a) After nomination in open Council, the Clergy and Laity shall ballot by Orders, and a majority of each Order on the same ballot shall be necessary to elect, provided that two-thirds of each Order is present.
- (b) If fewer than two-thirds of the members of an Order entitled to vote are present at the Council, the vote of two-thirds of those present in such Order shall be necessary for that purpose.

NOW, THEREFORE, the Committee does hereby adopt the following resolution and refers the same to the 197th Annual Council of the Diocese for consideration and adoption.

Resolution on Procedures for Election of the Eleventh Bishop of Mississippi

BE IT RESOLVED that the following procedures be adopted by the Annual Council, for the nomination and election of a Bishop for the Episcopal Diocese of Mississippi, at its 197th Annual Council to be held at St. Andrew's Episcopal School, Upper Campus, Ridgeland, Mississippi, on February 3, 2024. If there is no election on February 3, 2024, an additional reconvened Council will be held at St. Andrew's Episcopal Cathedral in Jackson, Mississippi on February 10, 2024.

A. At the beginning of the Saturday, February 3, 2024, business session of the 197th Council, the Standing Committee of the Episcopal Diocese of Mississippi will place in nomination all candidates selected by the Search Committee and all candidates processed through the Petition Process. No additional nominations for Bishop will be allowed.

- B. Balloting shall be done in the following manner:
- 1. The voting members of Council (the clergy and lay delegates, or alternates substituting for delegates), shall sit in a section reserved for them. This will be open seating and not a reserved section for each church.
- 2. At the time a ballot is called, a ballot shall be electronically presented onscreen within sight of each voting member of Council; clerical and lay ballots will clearly be identified as such, or as announced by the Chair, a single unified ballot may be presented which can be divided by Order (clerical or lay) by means of the assigned electronic voting device.
- 3. The voting member shall mark the nominee of choice electronically as instructed; and remain seated.
- 4. Once the presentation of ballots to the voting members of Council begins, no voting member may leave the floor and no change can be made in the certification of lay delegates. At such time as all the ballots have been marked and submitted electronically and the Council awaits the results of the ballot, voting members may leave the floor but will have to present their credentials to re-enter the voting area.
- 5. The votes shall be tabulated by the Standing Committee of the Diocese of Mississippi and their appointees, who will report the results of the same to the Chair of Council, with a copy in writing, together with a record of the individual ballots, which shall be filed with the Secretary.
- 6. A Nominee may remove his or her name from the ballot at any time during the voting by advising the Secretary in writing, by telephone, text or by email message signed by the Nominee. A wet signature (for notification in writing) or unique, electronic signature (for notification via text or email) shall suffice in fulfillment of this requirement. Once a Nominee has withdrawn, his or her name may not be re-entered on the ballot.

- C. At such time as there shall be a declaration of an election according to Article XIII of the Constitution of the Diocese of Mississippi, the Chair shall notify the elected person, obtain the elected person's acceptance of election, and shall make provision to notify the other candidates. All voting members of Council shall sign each of the six blank canonical Testimonials of Election and he or she shall ask that a motion be made from the floor that the Standing Committee of the Diocese be instructed to forward to the House of Bishops and to the Standing Committees of all dioceses in the Episcopal Church the canonical testimonials and certificates required by the Canons of General Convention evidencing the election, and to do all other things necessary to ensure the ordination of the Bishop Diocesan-Elect before Council shall be adjourned.
- D. It is the express intent of the Council that any election of a nominee to be the Bishop Diocesan of the Diocese of Mississippi is made in reliance upon full, truthful and complete disclosures by that Nominee to the Search Committee, Transition Committee, Office of the Chancellor and the Council. If, after the election but prior to consecration, the Council concludes that the Bishop-Elect has failed in any material way to provide full, truthful and complete disclosures, or if the Council concludes that the Bishop-Elect has omitted to disclose material facts, then the Council, acting pursuant to a notice of Council called for such purpose, may take action to rescind such election.
- E. A copy of this resolution shall be published in the November 2023, December 2023, and Council editions of The Mississippi Episcopalian.


